



## **2008 POWER Program**

With the upcoming elections, this will be an active year for NTEU members, both legislatively and politically. There is much work to be done in 2008 on Capitol Hill and in the election field to ensure that federal employees are treated fairly and with respect. We must make sure our legislative committees are engaged and fully participating in the legislative process. We need to continue to register voters, educate NTEU members and co-workers and get out the vote, be seen and heard in the offices of our Members of Congress and make sure NTEU's voice on legislative issues continues to be strong. The goal of the 2008 POWER Program is to strengthen chapter legislative programs and to engage chapters in the 2008 Presidential elections.

Attached is a copy of the reporting form to be used by your chapter for participation in NTEU's POWER Program, which recognizes achievement in legislative and political activities. NTEU urges all chapters to participate in the POWER Program, as your reporting forms provide valuable information, which NTEU's legislation department can use in pursuit of pro-federal employee policy on Capitol Hill. **NTEU needs your reports to get information on what is taking place in your locale. It is critically important that you participate.**

Please note that the point structure for the 2008 POWER Reporting form has changed and new questions have been added. The "Chapter profile", on the 3<sup>rd</sup> page of this report, which asks for general chapter information, needs to be filed only once a year. The deadline for filing the "chapter profile" is August 1, 2008. Chapters may report subsequently on chapter legislative and political activity by using pages 4 through 7 of the form to file comprehensive reports as the year progresses.

**Again, please file your Chapter Profile (page 3 of this report) by August 1, 2008.**

### **Comprehensive Reporting Periods:**

January 1, 2008 – June 30, 2008 → File report by August 1, 2008

July 1, 2008 – December 31, 2008 → File report by January 9, 2009

Rules and Incentives for the 2008 POWER Program:

- All chapters that file POWER Reports for **both reporting periods earn an invitation to a special event** with the National President during the legislative conference to discuss legislative and political issues.
- POWER participating chapters will also be invited to participate in a **semi-annual conference call** with NTEU's President and national legislative staff to discuss current legislation. More information about the conference call will be provided to POWER participants following the August 1, 2008 reporting deadline.
- All chapters participating in POWER will be highlighted in the NTEU Bulletin.
- Chapters continue to be divided into divisions by size, with **high scoring chapters receiving plaques** commemorating their achievements.
- **Reimbursements of up to \$1,000 for travel to the Legislative Conference** will be awarded to the high scoring chapter in each division and to the second highest-scoring chapter in those divisions in which more than 10 chapters participate.
